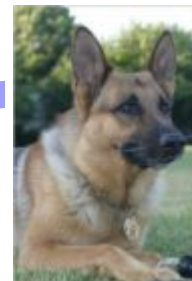

ELIGIBILITY:

This tournament is open to all male and female contestants at least six (6) years of age on the day of the competition. All contestants must be registered members and in good standing with the United States Judo Federation (USJF), United States Judo, Inc. (USJI), or the United States Judo Association (USJA).

All contestants must present their valid USJF, USJI, or USJA registration card, with acceptable proof of insurance at the time of registration.

IMPORTANT NOTE: If a contestant is unable to present a valid registration card, the contestant will be required to purchase a USJF membership at the tournament site before the contestant will be eligible to register to compete at this tournament.

Responsibility for reimbursement of the registration fee, if applicable, will be between the contestant and USJF.

TIME SCHEDULE:

8:30 to 9:30	Registration and weigh in for 6-10 year olds
8:30 to 10:00	Registration and weigh in for 11-12 year olds
8:30 to 11:00	Registration and weigh in for all other contestants
9:00 to 9:30	Official's meeting held at designated Hospitality room
10:00	OPENING CEREMONY FOLLOWED BY COMPETITION

ENTRY FEES:

\$25.00 fee for individual entry. Make personal checks payable to "Vacaville Police Activities League" (VPAL).

There will be a \$15.00 charge on all returned checks. Entry fee must be paid in full at time of registration. There will be **NO REFUNDS!**

Precondition of the acceptance of the entry fee: Entry fee will only be accepted with fully completed required forms as follows:

2009 TOURNAMENT FORMAT AND RULES

United States Judo Federation Sanction #09-02-01

POOLING:

All contestants will be grouped in pools, according to age, weight, and rank. Every effort will be made to provide competitors with the maximum number of matches with opponents of roughly same size and ability, although this will not be possible in all cases. It is the responsibility of the competitor and or their coach to check pools when called to insure the safety of their students. If a participant decides not to compete, after registration, their entry will be withdrawn. There are **NO REFUNDS!**

COMPETITION RULES:

The matches will be conducted using the current Contest Rules for Judo as stipulated by the International Judo Federation (IJF), with the following modifications:

1. Shimi-Waza (choking techniques) will be allowed with contestants 13 years of age or older only.
2. Kansetsu-Waza (joint lock techniques) will be allowed in the Black Belt divisions only.
3. The applications of #1 or #2 will result in Hansoku Make and the contestant will forfeit that match.
4. Pre-1994 contest rules for safety zone and out of bounds area

Match Time will be as follows:

Black Belts:	5 minutes
	(5 minutes for head to head match)
All other matches	3 minutes
	(3 minutes for head to head match)

Match scoring will be as follows:

Ippon	5 points
Wazari	4 points
Yuko	3 points
Koka	2 points
Decision	1 point

(no golden scoring, all matches based on match time limit)

TIE: In case of a tie for first place, second place or third place, there will be a head-to-head match to determine the first, second or third place winners.

Awards:

1. Places will be awarded by the following criteria, in this order
 - a. Most wins
 - b. Most points, if wins are tied
 - c. Result of head to head match, if wins and points are tied
2. First, second, and third place awards will be given in each division.

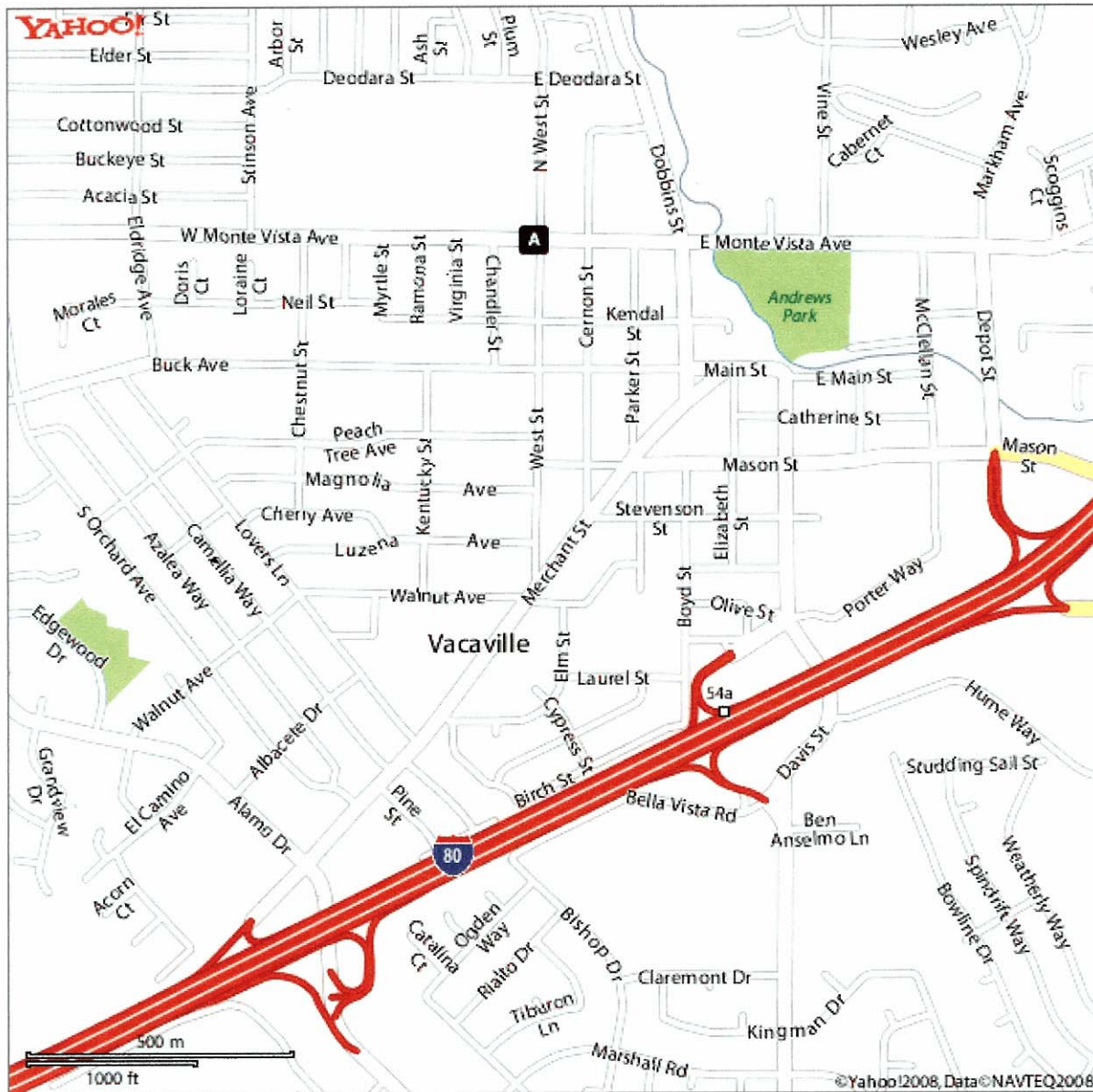

From Sacramento area: I-80 west bound. Take Mason Street Exit. Go straight onto Depot. Left turn on E. Monte Vista. Continue until Vacaville High School on right.
