**ELIGIBILITY:**

This tournament is open to all male and female contestants at least five (5) years of age on the day of the competition. All contestants must be registered members and in good standing with the United States Judo Federation (USJF), United States Judo, Inc. (USJI), or the United States Judo Association (USJA).

All contestants must present their valid USJF, USJI, or USJA registration card, with acceptable proof of insurance at the time of registration.

**IMPORTANT NOTE:** If a contestant is unable to present a valid registration card, the contestant will be required to purchase a USJF membership at the tournament site before the contestant will be eligible to register to compete at this tournament.

Responsibility for reimbursement of the registration fee, if applicable, will be between the contestant and USJF.

## 2010 MAKIMOTO JUDO CLUB TOURNAMENT FORMAT AND RULES

### POOLING:

#### Weights:

5-6yrs / 7-8yrs / 9-10yrs / 11-12yrs.....Light / Medium / Heavy  
13-14yrs /15-16 yrs..... Light / Medium / Heavy  
Sr White, Yellow, Green, Orange, Blue belts....Light / Medium / Heavy  
Sr. Brown / Black Belts..... Light / Medium / Heavy

All contestants will be grouped in pools, according to age, weight, and rank. Every effort will be made to provide competitors with the maximum number of matches with opponents of roughly same size and ability, although this will not be possible in all cases. It is the responsibility of the competitor and or their coach to check pools when called to insure the safety of their students. If a participant decides not to compete, after registration, their entry will be withdrawn. There are **NO REFUNDS!**

### COMPETITION RULES:

The matches will be conducted using the current Contest Rules for Judo as stipulated by the International Judo Federation (IJF), with the following modifications:

1. Shimi-Waza (choking techniques) will be allowed with contestants 13 years of age or older only.
2. Kansetsu-Waza (joint lock techniques) will be allowed in the Black Belt divisions only.
3. The applications of #1 or #2 will result in Hansoku Make and the contestant will forfeit that match.
4. Pre-1994 contest rules for safety zone and out of bounds area

Match Time will be as follows:

Black Belts:                      5 minutes  
(5 minutes for head to head match)

All other matches                3 minutes  
(3 minutes for head to head match)

Match scoring will be as follows:

Ippon	5 points
Wazari	4 points
Yuko	3 points
Koka	2 points
Decision	1 point

(no golden scoring, all matches based on match time limit)

TIE: In case of a tie for first place, second place or third place, there will be a head-to-head match to determine the first, second or third place winners.

Awards:

1. Places will be awarded by the following criteria, in this order
  - a. Most wins
  - b. Most points, if wins are tied
  - c. Result of head to head match, if wins and points are tied
2. First, second, and third place awards will be given in each division.

1. I understand the nature of Judo activities and believe I am qualified to participate in such Activity. I also understand the rules governing the sport of Judo.
2. I further acknowledge that prior to participating, I will inspect the mats, equipment, facilities, competition pools or divisions, and the elimination or scoring system to be used, and if I believe anything is unsafe or beyond my capability, I will immediately advise my coach, supervisor, and/or a tournament official of such conditions and refuse to participate.
3. I acknowledge and fully understand that I will be engaging in a contact sport that might result in serious injury, illness or disease, including permanent disability or death, and severe social and economic losses due not only to my own actions, inactions or negligence, but also to the actions, inactions, or negligence of others, the rules of the sport of Judo, or conditions of the premises or of any equipment used. Further, I acknowledge that there may be other risks not known to me or not reasonably foreseeable at this time.
4. Knowing the risks involved in the sport of Judo, I assume all such risks and accept personal responsibility for the damages following such injury, illness, disease, permanent disability, or death.

5.
